#### **Procedural Business**

Senator Whiting convened the regular, statutory meeting of the Administrative Rules Review Committee (ARRC) at 9 a.m. on Friday, May 7, 2021, in Room 103, State Capitol, Des Moines, Iowa. The minutes of the April 9, 2021, meeting were approved. The next meeting was scheduled for June 8. Mr. Ewing discussed procedures for those participating in the meeting via Zoom. He briefly reviewed the LSA rules analysis report for the bills enacted in the 2020 Legislative Session. He also reviewed the status of the technical bill sponsored by the ARRC. The meeting was adjourned at 11 a.m.

Committee members inquired about the origin of the new definitions included in the rulemaking. Mr. Young replied that the attorney general's office provided guidance on the definitions. Members stated that the department cites Iowa Code chapter 272C and Iowa Code section 103.6 as authority for the rulemaking; however, the definitions are not in either. Mr. Young responded that he will speak with the Attorney General's office and follow up with the committee.

Committee members stated that "rehabilitation" as described in rule 502.8(1)(c) is a misstatement of the law, and contrary to the description, in some circumstances the burden is not on the applicant to prove by clear and convincing evidence that the applicant is rehabilitated. Mr. Young stated that he will bring the matter to the attention of the Attorney General's office and report back to the committee. No action taken on ARC 5587C.

Committee members asked how the board educates pharmacies and individuals to ensure that they are aware of the registration requirements for pharmacy support persons. Ms. Mears explained that at both the notice and the adopted stages of rulemaking, the board puts out a press release regarding the rulemaking. She stated that the board's compliance officers speak to pharmacy personnel about new rulemaking during audits, and the department also distributes a quarterly newsletter to all licensees that provides information on rulemaking. She confirmed that the onus is on the pharmacy to ensure that all of its pharmacy support persons are properly registered.

Committee members asked how large the backlog is for solar energy system tax credits for eligible installations. Ms. Wulfsen replied that she will obtain that information and provide it to the committee. Members asked Ms. Wulfsen if she is aware of people who have installed separate meters in order to receive additional tax credits. She stated that she does not know how many instances of separate meter installations have occurred. Members commented that the wait list seems to be due to the popularity of the solar tax credit.

Mr. Christopher Rants, representing the Iowa Solar Energy Trade Association (association), thanked the department for its work on the rulemaking. He stated that the association supports the rulemaking; however, unless the General Assembly takes action before it adjourns sine die, the solar tax credit will end. He also stated that the association has proposed legislation and explained that based on information received from the department, 1,968 Iowans are on the wait list to receive the solar tax credit. He explained that despite those individuals applying for the solar tax credit and making the investment necessary to qualify for the credit, if the program expires, while some commercial applicants may still receive the solar tax credit, residential applicants will not. He stated that to remedy the issue, Iowa can either recouple with the federal extension, or decouple from the federal tax credit. He commented that the tax credit is very popular and has been used in all 99 counties, and he encouraged the committee to speak with other members of the General Assembly regarding legislation to remedy the issue. Members asked what the average tax credit is for those on the wait list, and he stated he would try to find out.

#### WORKFORCE DEVELOPMENT DEPARTMENT

Committee members asked how frequently a party files a request to reopen the record and also appeals to the Employment Appeal Board (EAB). Ms. Merrill responded that it is an infrequent occurrence as her team works closely with the EAB and tries to provide the EAB notice when a party requests to reopen the record. She stated that she receives feedback from the public that the process is very confusing. Members asked if a party can appeal to the EAB on the basis that the administrative law judge failed to consider an issue. Members provided an example of the appeal procedure in a district court. She explained that the administrative appeal process is more informal than the district court appeal process. She further explained that these administrative hearings involve parties who failed to appear for a hearing, and a party may appeal to the EAB for any reason. Members expressed concern that the rulemaking makes the administrative process more formal, and most claimants are not represented by counsel. Members also expressed concern that the rulemaking does not allow a presiding officer to vacate a decision upon the officer's own motion, and suggested that the department preserve that option.

Emergency Filing, Review Required: Broadband—Targeted Service Areas, Grants Program, Chs. 20, 22

Committee members asked if faster internet service results in lower reimbursement. Mr. Skepnek explained that all new projects have to support broadband download and upload speeds of 100/100 or 100/120, and reimbursement is pursuant to tier 1, 2, or 3 targeted service areas (TSA). Members asked if the fastest download speed is the tier 3 TSA. He explained that the reimbursement that is available for each TSA tier is dependent upon the download speeds already available in that TSA tier. He provided a hypothetical example of a project built in a rural part of the state where there is currently no broadband available in a census block and explained that the project would be eligible for a 75 percent tier 1 TSA reimbursement. He provided another hypothetical example of a project built in a tier 3 TSA that has existing broadband speeds between 50 and 80 mb/second and explained that the project would

be eligible for a 35 percent reimbursement. He indicated that the TSA tiers were established to help define the broadband speeds currently available in each census block.
