### VETERINARY MEDICINE BOARD

Committee members asked if a veterinarian that prescribed an antibiotic can be identified via the lot number on the antibiotic container. Dr. Rahe responded that the problem is that the veterinarian may be located in another state and signing blanket prescriptions despite the fact that the veterinarian has not been on the farm where the animals are located to inspect the premises and conduct a physical examination of the animals. Members asked if veterinarians located outside the state interpret the current rule as allowing them to write blanket prescriptions. He stated that the current rule is interpreted to allow both examination of patients and visits to the premises to be conducted remotely and that the rule needs more clarity. He asserted such remote visits and examinations are not sufficiently thorough. Members asked how the board determined that a physical examination and visit to a farm every 12 months is the appropriate frequency when a litter of pigs will not remain on a farm for 12 months. Dr. Rahe responded that the board engaged in detailed discussions regarding the frequency of examinations and visits. In addition, the board polled veterinary practices throughout the state and determined that 12 months was the standard. He explained that the rule is applicable to all species of farm animals and some species may remain on a farm for a year or more. Members asked if there is a licensure issue for out-of-state veterinarians who write prescriptions for farm animals located in Iowa. Dr. Rahe responded that there is not an issue, as the veterinarians are licensed in Iowa. He noted that under the new rule, the board will be able to review medical records to see if a veterinarian/ client/patient relationship exists in circumstances where an out-of-state veterinarian writes a prescription for farm animals located in Iowa. Under the current rule, a veterinarian could argue that being physically present for an examination was not medically appropriate.
