Procedural Business

Senator Brown convened the regular, statutory meeting of the Administrative Rules Review Committee (ARRC) at 9 a.m. on Friday, January 6, 2023, in Room 116, State Capitol, Des Moines, Iowa. The minutes of the December 12, 2022, meeting were approved. The next meeting was scheduled for Monday, February 13, 2023, at 9 a.m. Mr. Ewing provided an updated list of agencies that had not yet submitted their summaries of their five-year reviews of rules pursuant to Iowa Code section 17A.7(2) to the committee. He noted two of the agencies seemed to no longer exist. Committee members asked if the two agencies should be repealed in the legislation being considered for sponsorship by the committee. He was unsure if the two agencies may still have outstanding financial obligations that might complicate a repeal. Members indicated this should not be included in the legislation. He then reviewed a draft of a bill concerning updates and clarifications regarding the rulemaking process for consideration and possible sponsorship by the committee and solicited feedback from members. Members suggested adding a January 1, 2024, effective date. Members voted to approve the draft for sponsorship and filing with the addition of the effective date. The meeting was adjourned at 1 p.m.

Mr. Seth Brown, representing the Iowa Pharmacy Association (IPA), thanked the division for its efforts and collaboration. Mr. Brown stated that the IPA is in favor of requiring pharmacy benefits managers (PBMs) to establish internal data collection systems to analyze metrics and to analyze quarterly complaint summaries. He also stated that the IPA favors preventing direct or indirect clawbacks by PBMs claiming adjustment reconciliation, and the continued inclusion of various timing clarifications to ensure compliance by PBMs. He noted that the United States Supreme Court has ruled that states can regulate PBMs' activities.

Mr. Doug Struyk, speaking on behalf of the Pharmaceutical Care Management Association (PCMA), thanked the division for its efforts and for working with PCMA on the rulemaking. He stated that PCMA had provided both oral and written comments on the rulemaking, and the division had addressed several of PCMA's main concerns. Mr. Struyk noted that Mr. Brown repeatedly mentioned "legislative intent" and that IPA had been registered in opposition to 2022 Iowa Acts, House File 2384. He stated that IPA is now in favor of the rulemaking because IPA was able to accomplish in rules what it was unable to accomplish via legislation. He further stated that PCMA believes that the rulemaking exceeds the enabling statute, however, PCMA will continue to work with the division to address PCMA's concerns. He noted that there is additional rulemaking that has been noticed, and he reiterated PCMA's concern that rulemaking will also exceed the terms of the statute.

Mr. Peter Fjelstad, speaking on behalf of PCMA, stated that the rulemaking exceeds both the enabling statute and 2022 Iowa Acts, House File 2384, specifically, the definitions of "complaint" and "clean claim", the language within the termination or suspension of contracts with pharmacies, the record system, the quarterly compliant summery, disclosure of payments received by PBMs, and the disclosure of a PBM's payment methodology. He stated that neither the United States Supreme Court nor the Eighth Circuit Court of Appeals have narrowed Employee Retirement Income Security Act (ERISA) preemption.

Committee members stated that it is obvious the division tried to strike a delicate balance between the interested parties and asked the division to comment on that as well as the effect the rulemaking will have on patients. Commissioner Ommen responded that the division reached out to interested parties shortly after 2022 Iowa Acts, House File 2384 was enrolled. He acknowledged that there are legal issues around the ERISA component and stated that the division is receiving legal advice from the attorney general's office. He also stated that the division must carry out the legislative intent. He noted that the division considers comments, however, the rulemaking is an important step forward. He said that consumers are impacted by the complicated relationships between PBMS, manufacturers, and pharmacies. This is a complicated area and this area is controlled by a small number of PBMs. Members stated that the intent of the legislation was patient focused, and not focused on the PBMs or insurance companies. Families are paying too much for drugs and should be at the center of this conversation. Commissioner Ommen responded that the division will continue to carry out legislative intent.

Committee members asked if there is any data on the number of students who open enroll to multiple school districts in a single year. Mr. Mayes explained that the department only has anecdotal evidence and cannot track this more thoroughly because the open enrollment billing cycle is still open. He stated he could provide such data at a later time. He noted that he had heard from some school business officials of students who were on their third school district in the current school year.

Committee members asked if school districts had expressed concern about losing track of students due to multiple open enrollments within a short time period. Mr. Mayes responded that he had only heard concerns about billing, which the department sought to address in the rulemaking. He noted that open enrollment requests remain valid for one calendar year. Members asked if the department is aware of how many students open enrolled into an online program this school year. He stated that information could be obtained at a later date and would not include students who open enroll into an online program in their home district.

Committee members asked if there is any concern from school districts about financial tracking in regard to open enrollment. Mr. Mayes explained that there are concerns about the lack of a predictable timeline and that while the billing timeline remains the same, count dates differ. He further explained that the department has worked with the Iowa Association of School Business Officials to build internal procedures to maintain accurate billing. He noted that unique student identifiers will help with open enrollment billing. Members stated that any information the department can provide to school districts will be helpful.
