#### The Capitol Planning Commission is authorized under Chapter 8A.371—378 of the Code of Iowa.

"It shall be the duty of the commission to advise upon the location of statues, fountains and monuments and the placing of any additional buildings on the capitol grounds, the type of architecture and the type of construction of any new buildings to be erected on the state capitol grounds as now encompassed or as subsequently enlarged, and repairs and restoration thereof, and it shall be the duty of the officers, commissions, and councils charged by law with the duty of determining such questions to call upon the commission for such advice.

"The commission shall, in cooperation with the director of the department of administrative services, develop and implement within the limits of its appropriation, a five-year modernization program for the capitol complex.

"The commission shall annually report to the general assembly its recommendations relating to its duties under this section. The report shall be submitted to the chief clerk of the house and the secretary of the senate during the month of January."

## **Executive Summary**

The Capitol Planning Commission has spent many hours studying the location of statues, fountains and monuments, and the placing of buildings on the capitol grounds; including the type of architecture and construction of any new buildings as well as the restoration of existing buildings and monuments. This study has culminated in the 2010 Master Plan Update. The Capitol Planning Commission respectfully requests that legislators

familiarize themselves with the 2010 Master Plan Update as well as this 2010 Capitol Planning Commission annual report.

This 2010 Annual Report further summarizes the work of the Commission during the last year and provides planning recommendations for the future of the Capitol Complex. Please note that Iowa Code Chapter 8A.373 provides that, before any physical changes are made to the state capitol complex "it shall be the duty of the officers, commissions, and councils charged by law with the duty of determining such questions to call upon" the Capitol Planning Commission for advice.

The Capitol Planning Commission members, as well as DAS Staff, welcome the opportunity to discuss future projects at the request of any legislator.

# **Building Renovation, Restoration and Placement**

## Master Plan Update

On January 7, 2010, the Capitol Planning Commission adopted the completed 2010 Master Plan for the Capitol Complex and presenting it to members of the legislature and others. The Master Plan will serve as a guiding document over the next 10 to 25 to 100 years. The plan replaces the 2000 Master Plan and was prepared with assistance from Confluence, a local landscape architecture and planning firm, in collaboration with Zimmer Gunsul Frasca Partnership, Jeffrey Morgan Architecture Studio, the Tilghman Group, and Snyder and Associates. Members of the planning team were involved in the development of the 2000 Master Plan. Beginning in early 2009, the consultants worked with the State to address short-term and long-term growth, safety and security, energy independence and sustainable design. They were charged with creating an iconic, worldclass, vision for the Capitol Complex, demonstrating a marriage of the State Capitol's historic characteristics with this world vision, current realities and projected needs.

The Iowa Chapter of the American Planning Association presented Confluence, the lead planning firm on the project, with the Daniel Burnham Award for a Comprehensive Plan for its work on the Master Plan.

## Iowa Utilities Board/Office of Consumer Advocate Building

The Commission has closely followed construction of the new office building for the Iowa Utilities Board and the Office of Consumer Advocate and members toured the building in October. When the 44,000-square-foot building is completed in early 2011 it will be one of the most energy-efficient office buildings in Iowa. It is designed to use 63% less energy than a typical office building, which will result in significant operational cost savings as well. The facility will feature daylight harvesting, native prairie restoration, solar panels, a geo-thermal well field, and on-site reuse of storm water, resulting in less runoff. The State will be applying for LEED Platinum certification, the highest ranking on the U.S. Green Building Council's scale.

The State took possession of the Mercy Capitol building on December 15, 2009. The Planning Commission sees Mercy Capitol as a transitional building that can provide office space for state agencies for the near future. More importantly, the land on which the building stands is important to meeting future needs of the State.

## Other Related Capitol Complex Projects

While the Master Plan provides a framework for the work of the Capitol Planning Commission, the success of any improvement project is in the details. In 2010, the Capitol Planning Commission meetings provided a forum for the Department of Administrative Services and others to discuss on-going improvement issues on the Capitol Complex, including discussions on the following projects:

- Parking Lot Improvements
  - The Wallace Building upper parking deck has been removed and the lower level parking area has been replaced with approximately 40 surface parking spaces.
  - DAS has requested additional funding from the Legislature to continue to improve and maintain are parking lots here at the Capitol Complex.
- Pending Issues—Recommendations and implementation timelines on the following issues are now addressed in the updated Master Plan and are dependent upon the availability of funds to allow these concepts to move forward:
  - Relocation of the Fleet Building. Relocation of the fleet gas station and the possible renovation of the Fleet Building for office or other uses have been discussed with the Commission. The Master Plan recommends relocation of these facilities off-complex within the next 10 years. A legislative initiative in 2010 called for the Department of Administrative Services to issue an RFP for relocation of the Fleet operations.
  - 707 East Locust (IACCT Building) and 709 East Locust (Row House). The Master Plan recommends removal of these two buildings as part of the final phase of the West Capitol Terrace project. Whether or not these buildings can be relocated remains to be seen. DAS has requested additional funding from the Legislature to continue with the 3rd phase of improvements. Demolition and/or removal of 707 and 709 East Locust at the west end of the Terrace is anticipated to take place in the spring of 2011.
  - The 2010 Master Plan recommends utilization of the recently acquired Mercy Capitol building as a transition space for offices and support services for the State until the property is needed for new facilities. Some functions have been relocated to the facility and the Commission supports continued and expanded utilization of the building.
  - The acquisition of other properties adjacent to the Capitol Complex is an ongoing discussion. The Master Plan recommends continued acquisition of properties so as to expand the boundaries of the complex to East 14<sup>th</sup> Street on the east, I-235 on the north, and Pennsylvania Avenue on the west.

 Related City of Des Moines Planning Issues—In October, Erin Olson-Douglas of the City of Des Moines planning staff, briefed the Commission on planning efforts in the East Village area and, in particular, in the newly designated Market District south of the East Village. With the extension of Martin Luther King, Jr. Parkway south of the Capitol Complex, redevelopment in this area will become an important consideration for the Capitol Planning Commission, the Department of Administrative Services and the Legislature.

# **Monuments and Site Features**

## Proposals for Monuments and Site Features

The Site Features Committee makes recommendations to the Commission on proposed monuments. The Committee has begun consideration of proposed plans:

• Relocation of the Peace Officer's Monument: The Department of Public Safety proposed moving the Peace Officer's Memorial from its current site north of the Lucas Building to a site northwest of the Public Safety Building. Some private fund raising has begun but the siting of the monument has not been finalized. This move is in keeping with the Master Plan, which calls for construction of a new office building at the current site of the monument. Also, as part of preliminary planning for the renovated Public Safety Building, a site directly north of the building was proposed for this monument. The site, now the location of the Fleet fueling station, is at the terminus of former Kasson Street and E. Walnut. These preliminary plans called for a complementary site feature anchoring east of the Public Safety Building at the terminus of former Kasson Street and E. Court Avenue.

The Site Features Committee expects to continue work on this project in 2011.

#### Boulder Honoring Teachers:

The Commission received a preliminary proposal from the Iowa Association of Health Physical Education Recreation Group to install a boulder on the hill north of West Capitol Terrace in honor of Iowa teachers. The rock would be in the vicinity of the boulder designating the former location of the Bryant School.

No further action has been taken pending further information from the sponsor.

#### • Wind Turbine for IUB/OCA Building:

The Iowa Utilities Board has been awarded a federal stimulus grant from the Office of Energy Independence to construct a wind turbine south of the new Iowa Utilities Board and Office of Consumer Advocate Building. The wind turbine proposal is in keeping with the goal to construct a model energy-efficient building. Staff members from the Iowa Utilities Board provided preliminary information to the Site Features Committee and to the Capitol Planning Commission.

Additional information will be presented to the Commission before the project moves forward.

#### Restoration of Japanese Bell Memorial:

2011 marks the 50th anniversary of the Japanese Bell Memorial on the grounds of the Capitol Complex west of the Judicial Building. The structure was a gift to the State by grateful citizens of Yamanashi Prefecture in Japan after the famous "hog lift," which delivered swine breeding stock to Japan after devastating floods in 1959. The Iowa Sister States is spearheading fund raising for repairs and maintenance to the structure in preparation for a visit to the site by the Governor of Yamanashi Prefecture in August, 2011.

The Commission supports the funding-raising effort and asks the Legislature to make up any shortfall in private fundraising to repair and endow the maintenance of the Japanese Bell Memorial.

# **Modernization Program for the Complex**
