# **Department of Human Services**

**ARC 4673C (NOIA)** 

**Rule Summary** Requires both managed care and fee-for-service Medicaid payment and delivery

systems to utilize a uniform process, including but not limited to uniform forms, information requirements, and time frames, to request medical prior authorizations under the Medicaid program.

State or Federal Law Implemented: Iowa Code chapter 249A and 2019 Iowa Acts,

chapter 85 (FY 2020 Health and Human Services Appropriations Act).

**Fiscal Impact** Agency Response: No fiscal impact.

**LSA Response:** The LSA concurs.

ARC 4675C (NOIA)

Rule Summary Implements a new chapter to centralize administrative rules and amends cross

references regarding timely and adequate notices.

State or Federal Law Implemented: lowa Code section 217.6.

ARC 4674C (NOIA)

**Rule Summary** 

Revises appeal rules to simplify, provide uniformity, clarify the scope, clearly define appeal rights, and protect self-represented litigants. The Department has sought to eliminate redundancies and ambiguities, streamline processes across programs where permissible under state and federal law, explicitly clarify the circumstances in which contested case hearings are granted, ensure conformity with substantive federal and state standards, and inclusion of procedural protections for self-represented litigants.

State or Federal Law Implemented: Iowa Code chapter 17A and section 217.6.

**Rule Summary** 

Updates the Insurance Division's rules by adding and clarifying statutory requirements and eliminating rules that are duplicative of statutes. Updates the address, the website, and several out-of-date email addresses for the Division.

State or Federal Law Implemented: lowa Code chapters 17A, 22, 502, and 505.

ARC 4677C (AF)

**Rule Summary** 

Provides guidance to residential service companies and motor vehicle service companies regarding how their current license or registration status will be administered by the Division following the enactment of 2019 Iowa Acts, Senate File 619 (Service Contracts Act).

**State or Federal Law Implemented:** Iowa Code chapters <u>516E</u> and <u>523C</u> and 2019 Iowa Act, Senate File 619.

Fiscal Impact

Agency Response: No fiscal impact.

**LSA Response:** The LSA concurs in part. While the rulemaking itself has no fiscal impact to the Insurance Division or to the State General Fund, <u>Senate File 619</u> will result in an annual estimated net increase of \$111,800 in Other Funds revenue beginning in FY 2020, as outlined in the <u>Fiscal Note</u> for the Act. Two-thirds of residential service contract fee revenue will be deposited into the Commerce Revolving Fund. The Act creates the Service Company Oversight Fund, which will receive the remaining one-third of all residential service contract fee revenue. This is expected to result in an annual estimated net decrease of \$97,000 in Commerce Revolving Fund revenue beginning in FY 2020.

Act), and makes a technical correction.

Rule Summary Adds definitions for the terms "administer," "dispense," "order," and "prescribe" to clarify

the distinction between different actions related to Schedule II controlled substances

that are listed as depressants in Iowa Code chapter 124.

**State or Federal Law Implemented:** lowa Code chapter <u>148C</u>.

Fiscal Impact Agency Response: No fiscal impact.

ARC 4668C (NOIA)

Rule Summary Implements 2018 Iowa Acts, chapter 1138 (Opioid Regulation Act), by adding continuing

education and training requirements for renewal or reinstatement for an optometrist who

prescribes a controlled substance, requiring optometrists to check the prescription monitoring program prior to prescribing a controlled substance, and adding discipline that may be imposed.

State or Federal Law Implemented: lowa Code sections 124.551A and 147.162.

Rule Summary Amends the scope of practice for dental assistants and dental hygienists. Creates a new

chapter to contain all expanded functions rules and revises training requirements for expanded functions. Specifies that the fees for issuing duplicate licenses is only for hard

copies and electronic copies are provided at no cost.

State or Federal Law Implemented: lowa Code sections 153.15, 153.38, and 153.39.

# **Board of Medicine**

**ARC 4653C (NOIA)** 

Rule Summary Amends the list of debilitating medical conditions eligible for the Medical Cannabidiol

Program. Expands the current condition of severe, intractable pediatric autism with self-

injurious or aggressive behaviors by removing the word "pediatric."

**State or Federal Law Implemented:** lowa Code chapter <u>124E</u>.

Fiscal Impact Agency Response: No fiscal impact.

Rule Summary Adds corticobasal degeneration to the list of debilitating medical conditions for which

medical cannabidiol may be used.

State or Federal Law Implemented: lowa Code chapter 124E.

ARC 4663C (NOIA)

**Rule Summary** Establishes the standards of practice for physicians who supervise a conditional

prescribing psychologist and physicians who collaborate with a prescribing psychologist pursuant to 2016 Iowa Acts, chapter 1112 (Prescription Authority for Psychologists Act).

State or Federal Law Implemented: Iowa Code chapters 17A, 124, 147, 148, 154B,

and <u>272C</u>.

Fiscal Impact Agency Response: No fiscal impact.

### **Department of Public Safety**

ARC 4650C (NOIA)

Rule Summary Amends existing rules regarding closed circuit surveillance systems to incorporate

sports wagering into the existing scheme of surveillance required of gambling activities in the State. The goal of these amendments is to ensure that surveillance systems are able to capture all sports wagering-related activities within approved areas of a casino.

State or Federal Law Implemented: lowa Code section 99F.4.

Fiscal Impact Agency Response: No fiscal impact.

ARC 4651C (NOIA)

**Rule Summary** Establishes parameters that will regulate the distribution of the Public Safety Survivor

Benefits Fund created in <u>Senate File 615</u> (FY 2020 Justice System Appropriations Act). Such parameters include the application process and how benefitting organizations will

be chosen by the Department.

State or Federal Law Implemented: 2019 Iowa Acts, Senate File 615, section 38.

Fiscal Impact Agency Response: No fiscal impact.

**LSA Response:** The LSA concurs.

ARC 4652C (NOIA)

**Rule Summary** Updates several processes within the Division of the State Fire Marshal, including

streamlining the appointment of the State Fire Marshal and amending the process for

building plan approvals and conducting fire investigations.

**State or Federal Law Implemented:** lowa Code section 100.1 and 100.18.

Fiscal Impact Agency Response: No fiscal impact.

ARC 4667C (NOIA)

Rule Summary Updates the Department's existing rules regarding vehicle impoundment to be in line

with the decision rendered in State v. Ingram, No. 16-0736 (Iowa 2018), which dealt with

the inventory of closed containers. The rulemaking makes additional changes to provide a clearer interpretation of when a vehicle may be impounded.

State or Federal Law Implemented: lowa Code sections 80.9(2) and 321.89.

# **Department of Revenue**

ARC 4678C (AF)

Rule Summary Requires that withholding agents only need to file W-2 and 1099 forms for employees

from whom tax was withheld. Moves the relevant filing deadline from January 31 to

February 15 annually.

**State or Federal Law Implemented:** lowa Code section <u>422.16</u>.

Fiscal Impact Agency Response: No fiscal impact.

LSA Response: The LSA concurs.

ARC 4679C (AF)

**Rule Summary** 

Implements an exemption from sales tax on specified digital products, prewritten computer software, and certain enumerated services sold or furnished to a commercial enterprise when used exclusively by the commercial enterprise pursuant to Iowa Code section 423.3(104) as enacted by 2018 Iowa Acts, chapter 1161 (State and Local Revenue and Finance Act). The rulemaking defines "de minimis" and "noncommercial purposes."

**State or Federal Law Implemented:** lowa Code section <u>423.3</u> and 2018 lowa Acts, chapter 1161.

Fiscal Impact

**Agency Response:** The impact of the exemption was not represented individually by the <u>Fiscal Note</u> for the Act, but was incorporated into the calculation for the additional revenue to be generated by the taxation of "digital goods" generally. Table 7 of the Fiscal Note for the Act projected additional revenue collection related to "digital goods" to be \$11.8 million for FY 2019, \$26.2 million for FY 2020, \$28.8 million for FY 2021, \$31.1 million for FY 2022, \$33.6 million for FY 2023, and \$35.6 million for FY 2024.

# **Department of Workforce Development**

ARC 4647C (NOIA)

**Rule Summary** 

Updates policies for collecting and recovering unemployment overpayment balances from claimants who have received benefits to which they were not entitled. Adds the ability to pay by credit card and specifies that the second notice should be a demand letter rather than another billing statement.

State or Federal Law Implemented: lowa Code chapter 96.

Fiscal Impact Agency Response: No fiscal impact.

LSA Response: The LSA concurs.

### ARC 4648C (NOIA)

#### **Rule Summary**

Rescinds a previous unemployment change that the Department has determined was not appropriate regarding the role of the administrative law judge in determining a disqualification for failure to report. The rule proposed to be rescinded specified that before an administrative law judge can rule on a disqualification for failure to report at an lowa workforce development center as directed, there must be evidence to show that the individual was required to report for an interview. This rulemaking also specifies that a claimant who was overpaid does not have that overpayment eliminated by the addition of claim weeks the claimant would otherwise have been ineligible to receive.

**State or Federal Law Implemented:** lowa Code chapter <u>96</u>.

Fiscal Impact Agency Response: No fiscal impact.

# ARC 4649C (NOIA)

#### **Rule Summary**

Specifies that a claimant who voluntarily quits supplemental part-time employment is not disqualified from other benefits the claimant may be entitled to. Updates calculations for the impact of vacation payments and pension payments. Modifies the rules related to fraudulent overpayments, offsets, and shared work programs. Also makes additional conforming changes.

State or Federal Law Implemented: lowa Code chapter 96.

# Fiscal Impact Agency Response: No fiscal impact.

**LSA Response:** The LSA concurs in part. Although the rulemaking has no fiscal impact, the legislation associated with it does. The updates of the impact of vacation payments and pension payments is implementing HF 2321 (Unemployment Compensation, Workforce Development Act) and the Fiscal Note states that the changes will permit the Iowa Department of Workforce Development (IWD) to reallocate an estimated 2.9 Workforce Advisor FTE positions and \$150,000 in salary expenses paid from the Unemployment Insurance Federal Base Grant in the Benefits Bureau. That estimate remains the same as stated in the Fiscal Note.

The modification of the rules related to fraudulent overpayments implement <u>HF 2493</u> (FY 2019 Economic Development Appropriations Act). That Act provided for the disqualification of a claimant from receiving Unemployment Compensation benefits until all benefits received by the individual by reason of nondisclosure or misrepresentation of a material fact have been paid in full. The impact of that change on the Unemployment Compensation Fund is a decrease in payments from the Fund and an increase in collections. Information is not available to determine the magnitude of the impact.

#### **Department of Public Health**

#### **ARC 4671C (NOIA)**

#### **Rule Summary**

Implements 2019 Iowa Acts, chapter <u>55</u> (Physician Workforce and Medical Residency Positions Act), that adds a grant preference for candidates who are residents of Iowa, attended and earned an undergraduate degree from an Iowa college or university, or attended and earned a medical degree from a medical school in Iowa. Adds requirement that the residency program offer the residency participants the opportunity to participate in a rural rotation.

**State or Federal Law Implemented:** Iowa Code section  $\underline{135.176}$  and 2019 Iowa Acts, chapter  $\underline{55}$ .

Fiscal Impact Agency Response: No fiscal impact.

**LSA Response:** The LSA concurs.

ARC 4672C (NOIA)

**Rule Summary** Implements 2019 Iowa Acts, chapter 85, section 98 (Health and Human Services

Appropriations Act), which directs the Department to apply for all grant funding received through Title X of the federal Public Health Services Act, and specifies the funding

prioritization, restrictions, and reporting requirements.

State or Federal Law Implemented: 2019 Iowa Acts, ch. 85.

Fiscal Impact Agency Response: No fiscal impact.

LSA Response: The LSA concurs.

ARC 4489C (AF)

**Rule Summary** Updates the Medical Cannabidiol Program by making the following changes:

 Adds a mechanism to update the list of debilitating conditions approved by the Board of Medicine.

- Adds and updates definitions.
- Adds health care practitioner prohibitions, including self-certifying, advertising certification services, or accepting remuneration beyond a consultation fee for certifying conditions.
- Permits the Department to waive the registration card requirement for patients who
  are unable to obtain a card due to health, mobility, or other issues, if the patient has a
  designated primary caregiver.
- Establishes procedures to allow patients and primary caregivers to cancel their registration cards.
- Establishes procedures for recall of medical cannabidiol products.
- Amends labeling requirements for manufacturers and dispensaries.
- Moves the laboratory testing regulations for manufacturers to the referenced Laboratory Testing Requirements and Acceptance Criteria Document.

**State or Federal Law Implemented:** lowa Code sections <u>124E.2</u>, <u>124E.4</u>, and 124E.11.

licensed in another state.

Iowa Acts, chapter 9.

- Rescinding a subrule regarding records relating to security procedures, emergency preparedness, and disaster recovery, as the provisions are no longer applicable.
- Implementing changes relating to undercover driver's licenses for peace officers as enacted in 2017 lowa Acts, chapter 122 (Confidentiality of Law Enforcement Officer Information, Criminal Sentencing, and Massage Therapy Regulation Act).

**State or Federal Law Implemented:** lowa Code sections <u>22.7</u>(50), <u>80G.2</u>, and <u>80G.3</u> and 2017 lowa Acts, ch. 122.
