FUNDING SUMMARY

Appropriates \$14.0 million from the General Fund to the Department of Education (DE) for FY 2025 for supplement education support personnel compensation as provided for in 2024 Iowa Acts, [House File 2612](#) (Area Education Agencies Act), Section 52. Page 1, Line 4

Appropriates \$2.0 million from the General Fund and 12.0 full-time equivalent (FTE) positions to the Department of Public Safety (DPS) for direct support costs for agents and officers engaged in enforcement activities in gambling facilities. Page 2, Line 3

MAJOR INCREASES/DECREASES/TRANSFERS OF EXISTING PROGRAMS

Limits the FY 2025 General Fund appropriation to the DE for nonpublic school transportation to \$9.0 million. Requires the appropriation to be prorated if the claims exceed the appropriation. Page 1, Line 18

Suspends the General Fund standing appropriation of \$14.8 million to the DE for the Instructional Support Program for FY 2025. Page 1, Line 32

Transfers up to \$8.0 million from excess Economic Emergency Fund moneys to the General Fund in FY 2024 to replace an equal amount of other General Fund moneys to pay FY 2025 State school foundation aid as described in Iowa Code section [257.16](#). Provides that if the actual difference between the net revenue for the General Fund for FY 2024 and the adjusted revenue estimate for FY 2024 is less than \$8.0 million, an amount equal to the difference would also be transferred from the Taxpayer Relief Fund to the General Fund. Page 2, Line 29

If that amount is greater than the \$8.0 million, an amount equal to the difference will be transferred to the Taxpayer Relief Fund. All remaining funds in excess of the maximum balance of the Economic Emergency Fund will be transferred to the General Fund.

Transfers \$13.9 million from the Taxpayer Relief Fund to the General Fund to be used to pay the FY 2025 State school foundation aid as described in Iowa Code section [257.16](#). Page 3, Line 19

Reduces General Fund standing unlimited FY 2025 State school aid funding specified in Iowa Code section [257.35](#) to Area Education Agencies (AEAs) and school districts by \$15.0 million. If 2024 Iowa Acts, [Senate File 2435](#) (FY 2025 Education Appropriations Bill), is enacted, an additional \$10.0 million will be reduced. Page 4, Line 10

If SF 2435 is enacted and the additional \$10.0 million reduction is made, the State aid reduction to the AEAs and school districts will total \$32.5 million for FY 2025. Funding for FY 2024 was reduced by \$22.1 million.

SIGNIFICANT CODE CHANGES

Specifies that the distribution of the reduced General Fund standing unlimited FY 2025 State school aid funding specified in Iowa Code section [257.35](#) to AEAs must include a proportional reduction for the school districts and AEAs based on the amount of funding received. Page 3, Line 31

Adopts corrective provisions to the 2024 Iowa Acts contingent upon enactment. Page 4, Line 35

Establishes July 1, 2024 (FY 2025), as the specific date by which a teacher must have at least 12 years of experience to qualify for the minimum teacher salary as established in 2024 Iowa Acts, [House File 2612](#) (Area Education Agencies Act), in Section 46 of the Act. Page 11, Line 11

Establishes July 1, 2025 (FY 2026), as the specific date by which a teacher must have at least 12 years of experience to qualify for the minimum teacher salary as established in 2024 Iowa Acts, [House File 2612](#), in Section 46 of the Act. Page 11, Line 27

EFFECTIVE DATE

Specifies that Section 6 of the Bill relating to the distribution from the Economic Emergency Fund and Section 8 of the Bill relating to the reduction in funding for the AEAs and the school districts are effective upon enactment. Page 4, Line 24

Specifies that the following sections of this Bill take effect upon enactment: Page 9, Line 33

1 4 Section 1. DEPARTMENT OF EDUCATION — EDUCATION SUPPORT
 1 5 PERSONNEL SALARY SUPPLEMENT — FY 2024-2025. There is
 1 6 appropriated from the general fund of the state to the
 1 7 department of education for the fiscal year beginning July
 1 8 1, 2024, and ending June 30, 2025, the following amount, or
 1 9 so much thereof as is necessary, to be used for the purposes
 1 10 designated:
 1 11 To supplement education support personnel compensation, as
 1 12 described in 2024 Iowa Acts, House File 2612, section 52:

General Fund appropriation to the Department of Education (DE) for FY 2025 to supplement education support personnel compensation as provided for in 2024 Iowa Acts, [House File 2612](#) (Area Education Agencies Act), Section 52.

DETAIL: This is a new appropriation for FY 2025.

1 14 Moneys appropriated in this section are miscellaneous income
 1 15 as defined in section 257.2 and shall not be included in any
 1 16 computation of district cost under chapter 257 for any budget
 1 17 year.

Requires the appropriation for supplemental education support personnel compensation to be considered miscellaneous income and provides that it is not to be included in any computation of district cost.

1 18 Sec. 2. LIMITATIONS OF STANDING APPROPRIATIONS — FY
 1 19 2024-2025. Notwithstanding the standing appropriation in the
 1 20 following designated section for the fiscal year beginning July
 1 21 1, 2024, and ending June 30, 2025, the amount appropriated from
 1 22 the general fund of the state pursuant to that section for the
 1 23 following designated purpose shall not exceed the following
 1 24 amount:
 1 25 For payment of claims for nonpublic school pupil

CODE: Limits the FY 2025 General Fund appropriation to the DE for nonpublic school transportation to \$8,997,091. Requires the appropriation to be prorated if total school district claims exceed the appropriation.

DETAIL: This is no change compared to estimated FY 2024. This also represents a decrease of \$5,752,909 compared to the estimated standing unlimited appropriation of \$14,750,000 based on current law.

1 28 If total approved claims for reimbursement for nonpublic
 1 29 school pupil transportation exceed the amount appropriated in
 1 30 accordance with this section, the department of education shall
 1 31 prorate the amount of each approved claim.

1 32 Sec. 3. INSTRUCTIONAL SUPPORT STATE AID — FY 2024-2025. In
 1 33 lieu of the appropriation provided in section 257.20,
 1 34 subsection 2, the appropriation for the fiscal year
 1 35 beginning July 1, 2024, and ending June 30, 2025, for paying
 2 1 instructional support state aid under section 257.20 for the
 2 2 fiscal year is zero.

Suspends the General Fund standing appropriation of \$14,800,000 for the Instructional Support Program for FY 2025.

DETAIL: Although no State funding will be provided for the Instructional Support Program, school districts may use local property tax and income surtax to fund their portion of the Program. In FY 2024,

325 school districts implemented the Program and generated \$265,349,882 in local taxes (\$95,682,684 in income surtax and \$169,667,198 in property taxes). This Program has not been funded by the State since FY 2006.

2 3 Sec. 4. DEPARTMENT OF PUBLIC SAFETY. There is appropriated
2 4 from the general fund of the state to the department of public
2 5 safety for the fiscal year beginning July 1, 2024, and ending
2 6 June 30, 2025, the following amount, or so much thereof as is
2 7 necessary, to be used for the purposes designated:

2 8 For providing personnel to conduct coordination, oversight,
2 9 technical assistance, and investigatory assistance to current
2 10 or new task forces to address the rise in illegal immigration
2 11 and related criminal conduct such as drug trafficking and
2 12 human trafficking, or as assigned by the commissioner of
2 13 public safety, and for not more than the following full-time
2 14 equivalent positions:

Appropriates \$2,000,000 from the General Fund and 12.00 full-time equivalent (FTE) positions to the Department of Public Safety (DPS) for personnel to conduct coordination, oversight, technical assistance, and investigatory assistance to task forces to address the rise in illegal immigration and human trafficking.

DETAIL: This is a new appropriation for FY 2025

2 17 Sec. 5. SPECIAL FUNDS — SALARY ADJUSTMENTS — FY
2 18 2024-2025. For the fiscal year beginning July 1, 2024, and
2 19 ending June 30, 2025, salary adjustments otherwise provided
2 20 may be funded as determined by the department of management,
2 21 subject to any applicable constitutional limitation, using
2 22 unappropriated moneys remaining in the commerce revolving
2 23 fund, the gaming enforcement revolving fund, the gaming
2 24 regulatory revolving fund, the primary road fund, the road
2 25 use tax fund, the fish and game protection fund, and the Iowa
2 26 public employees' retirement fund, and in other departmental
2 27 revolving, trust, or special funds for which the general
2 28 assembly has not made an operating budget appropriation.

Permits salary adjustments to be funded from non-General Fund moneys remaining in various revolving, trust, or special funds for FY 2025 for which the General Assembly has not established an operating budget.

2 29 Sec. 6. DISTRIBUTIONS OF IOWA ECONOMIC EMERGENCY FUND
2 30 EXCESS — FY 2023-2024. Notwithstanding section 8.55,
2 31 subsection 2, paragraphs "a" and "b", for the fiscal year
2 32 beginning July 1, 2023, and ending June 30, 2024, moneys in
2 33 excess of the maximum balance of the Iowa economic emergency
2 34 fund created in section 8.55 shall be distributed as follows:
2 35 1. a. Based on the application of assessment limitations
3 1 calculated under section 441.21 due to the enactment of 2023

CODE: Transfers up to \$8,000,000 from excess Economic Emergency Fund moneys to the General Fund in FY 2024 to be used in lieu of a like amount of other General Fund moneys to pay FY 2025 State school foundation aid as described in Iowa Code section [257.16](#). Provides that if the actual difference between the net revenue for the General Fund for FY 2024 and the adjusted revenue estimate for FY 2024 is less than \$8,000,000, an amount equal to the difference would also be transferred from the Taxpayer Relief Fund to the General Fund.

3 2 Iowa Acts, chapter 5, of the amount that is the difference

3 24 2. The transfer made in this section is based on the
 3 25 application of assessment limitations calculated under section
 3 26 441.21 due to the enactment of 2023 Iowa Acts, chapter 5. The
 3 27 transferred moneys shall be used in lieu of a like amount
 3 28 of other general fund moneys to pay foundation aid under
 3 29 chapter 257 as described in section 257.16 for the fiscal year
 3 30 beginning July 1, 2024.

3 31 Sec. 8. Section 257.35, subsection 2, Code 2024, as amended
 3 32 by 2024 Iowa Acts, House File 2612, section 30, is amended to
 3 33 read as follows:

3 34 2. Notwithstanding the deduction and payment under
 3 35 subsection 1, the amounts specified for school districts and
 4 1 area education agencies in subsection 1, paragraph "a", for the
 4 2 fiscal year beginning July 1, 2024, and each succeeding fiscal
 4 3 year, shall be reduced by the department of management by seven
 4 4 million five hundred thousand dollars. The department of
 4 5 management shall calculate a reduction such that such amounts
 4 6 shall be reduced proportionally to the amount that the district

If the actual difference between the net revenue for the General Fund for FY 2024 and the adjusted revenue estimate for FY 2024 is greater than \$8,000,000, an amount equal to the difference will be transferred to the Taxpayer Relief Fund. All remaining funds in excess of the maximum balance of the Economic Emergency Fund will be transferred to the General Fund.

DETAIL: In FY 2023, \$21,881,303 was transferred from excess Economic Emergency Fund moneys to the General Fund for FY 2024 State school foundation aid. Up to \$8,000,000 that would otherwise be transferred to the Taxpayer Relief Fund in FY 2024 will instead be transferred to the General Fund to pay FY 2025 State school foundation aid.

Transfers \$13,881,303 from the Taxpayer Relief Fund to the General Fund to be used to pay the FY 2025 foundation aid as described in Iowa Code section [257.16](#).

DETAIL: Combined with the \$8,000,000 transfer from the Economic Emergency Fund, a total of \$21,881,303 would be transferred to the General Fund to replace an equal amount of other General Fund moneys to pay FY 2025 State school foundation aid.

CODE: Specifies that the distribution of the reduced General Fund standing unlimited FY 2025 State school aid funding specified in Iowa Code section [257.35](#) to Area Education Agencies (AEAs) must include a proportional reduction for the school districts and AEAs based on the amount of funding received.

CODE: Requires the Department of Management (DOM) to reduce General Fund standing unlimited FY 2025 State school aid funding specified in Iowa Code section [257.35](#) to AEAs and school districts by \$15,000,000. If 2024 Iowa Acts, [Senate File 2435](#) (FY 2025 Education Appropriations Bill), is enacted, the DOM will reduce the appropriation to AEAs and school districts by an additional \$10,000,000. The reductions for each AEA and school district will be prorated based on the proportional reduction the AEA or school district receives under Section 8, subsection 2, of the Bill.

DETAIL: In addition to the \$15,000,000 State aid reduction for FY 2025, the AEAs and school districts have an annual statutory reduction of \$7,500,000. If SF 2435 is enacted and the additional \$10,000,000 reduction is made, the State aid reduction to the AEAs and school districts will total \$32,500,000 for FY 2025. Funding for FY 2024 was reduced by \$22,057,131.

Specifies that Section 6 of the Bill relating to the distribution from the Economic Emergency Fund and Section 8 of the Bill relating to the reduction in funding for the AEAs and the school districts are effective upon enactment.

Specifies that Section 8 of the Bill relating to the reduction in funding for the AEAs and the school districts is applicable for school budget years beginning on or after FY 2025.

Adopts corrective provisions related to 2024 Iowa Acts, [Senate File 477](#) (Medical License, Internationally Trained Doctors Bill), in Section 4 of the Bill, if enacted.

DETAIL: This Bill was approved by the General Assembly on March 26, 2024.
