The Service Committee makes the following recommendations to the Legislative Council:

1. That pursuant to sections 601G.3, 601G.4, and 601G.5 of the <u>Code of Iowa</u> (1981) Mr. William P. Angrick II be reappointed as Citizens' Aide for a four-year term of office commencing July 1, 1982. The appointment will require House and Senate confirmation.

2. That a policy relating to prohibited political activities for employees of the Office of Citizens' Aide, issued by the Citizens' Aide on April 23, 1982, be held in abeyance by the Citizens' Aide until after the Service Committee has reviewed the policy. Since the Legislative Service Bureau and the Legislative Fiscal Bureau are also affected by the adoption of policies relating to political activities of employees, the directors of these two agencies were asked to submit their recommendations on political activities of employees together with any other information they deem useful.

3. That the Capitol Tour Guides be allowed to purchase summer uniforms at a total cost not exceeding \$200.

4. That Ms. Henrietta Macaulay be allowed to employe a temporary part-time tour guide at a cost of \$4.20 per hour for from fifteen to twenty hours per week from approximately June 7, 1982 until August 24 or 25 to fill in for vacationing tour guides. Ms. Macaulay agreed to contact the Department of Job Service to obtain the names of potential employees.

In addition, the Service Committee has received two grievances and has voted to meet in June to resolve the grievances filed by Ms. Linda Leon Hoffman, Legal Analyst, of the Office of Citizens' Aide and Ms. Virginia Sheffield, Principal Fiscal Analyst, of the Legislative Fiscal Bureau. The date of the meeting will be set by the Chairperson in consultation with the affected parties and based upon the time needed for the affected parties to submit additional information requested by the Committee.

The Studies Committee met on May 25, 1982 and recommends that the Legislative Council approve the following recommendations:

1. That the Council approve the attached list of 1982 interim studies with the number of members and meeting days specified.

2. That the emphasis of the Unemployment Compensation study be directed to maintaining the solvency of the fund and analysis of the tax structure and not the reduction in benefits.

3. That the Contract and Bidding Procedures study consider the subject matter in SCR 106, mainly the consolidation and uniformity fo bidding laws.

4. That the Legislative Procedures study consider matters within the scope of HCR 149 and also the drafting and assignment of study bills and fiscal note filings.

5. That the Court study direct its attention to the issues contained in the bill with particular emphasis on the issues of court funding and the clerks of court.

6. That the Subcommittee on the Productivity Formula meet with the Department of Revenue to review the progress of the Department with a possible meeting following the completion of the study to review the results of the study.

7. Other potential studies which the Studies Committee may consider include student loans (HCR 140), County finance and county compensation boards (SCR 121 and HCR 120), mass transit (SCR 103), equal pay for equal work (HCR 141), and the utility rate structure (SCR 135).

Because letters requesting studies were submitted to the members of the Studies Committee by interested parties at or during its May 25 meeting, The Studies Committee agreed that it would consider additional recommendations for studies at its next meeting.
