### PROPOSAL FOR ADDITIONAL COMPUTER CAPABILITIES IN LEGISLATIVE BILL DRAFTING

One Collins 8833B CRT (cathode ray tube) computer terminal and one IBM 2740 terminal would be installed in or near the offices of the Senate and House Legal Counsel. Such equipment is or soon will be in place in the Legislative Service Bureau.

During the course of each day all amendments prepared in the Senate or House would be entered in the respective terminal. Amendments prepared in the Legislative Service Bureau would be entered in their terminals -- some, but not all, amendments prepared by LSB during the recent Session have been entered in the terminal.

Later in the day, a Senate and House employee would begin to recall all Senate or House amendments introduced that day and prepare the clip sheet. This would be in lieu of Wallace-Homestead hiring two employees to retype all amendments, and proofread the same for the clip sheet. Once an amendment has been entered in the computer, it need never again be retyped or proofread, as it can be recalled from the computer at any time.

A significant savings in printing costs can be realized in this manner. For example, our projected 1975 cost for printing clip sheets is \$15.40 per page for 600 clip sheets. If the computer is utilized and camera-ready copy submitted to the printer, that cost drops to \$13.64 -- or a savings of \$1.76 per page. If 3000 pages of clip sheets are produced during a General Assembly, the savings is \$5,280.00.

In addition, the 8833B CRT terminal can be used by the Legal Counsel in drafting amendments. This terminal will recall on a screen sections of the Code or portions of a bill that already has been introduced. The Legal Counsel can call up the needed sections, enter instructions to the computer and the desired language changes, and then instruct the IBM 2740 terminal to print a hard copy, thus saving a significant amount of time.

One additional proposal involves the revision of the Service Bureau's existing computer program to provide the capability to apply -- by computer -- amendments to amendments, to amendments; and the resulting amendments to the bills. This would be possible, since all amendments would have been entered in the computer either in the Senate, the House, or the Service Bureau.

Hence, as soon as the Senate amends and passes a Senate File, the Service Bureau would be able to produce immediately a new copy of the bill to be sent to the printer to produce a pink reprint. At the present time reprinted bills are set in hot lead and printed at a projected 1975 cost of \$24.03 per page for 900 copies.

If the computer were utilized and camera-ready copy submitted for reprinted bills, the cost per page would drop to \$16.81 -- or a savings of \$10.22 per page. If 1500 pages of bills were reprinted over the course of a General Assembly, the total savings would be \$15,330.00. Much of this savings could be used to reprint more bills that are not now reprinted -- in short, all bills that are amended in the house of origination could be reprinted.

This additional computer capability would also significantly reduce the time taken for the enrolling process, particularly at the end of the Session when the Service Bureau has to wait for the Senate and House staff to "build" the bills.

Looking down the road, this process will also speed up production of the Code. The General Assembly this year appropriated \$30,000 to place the Code on computer. [Actually the Code is now on computer, but this would update the Code, and take a lot of "bugs" out of it.]

Once this is done, the bills approved by the Governor could be applied to the Code, hence saving hundreds, and perhaps thousands of hours of proofreading, and allow the Code to be printed several months ahead of its present delivery time.

Data Processing estimates the cost required to implement the capability to enter amendments and generate the clip sheets to be as follows:

In addition, terminals cost about \$154.00 each per month. It should be noted that the programming cost is not actually borne by the General Assembly, but comes out of the appropriation to Data Processing, a portion of which is assumed to be for work for the General Assembly. Also, the cost should be amortized over at least a ten year period.

The cost required to implement the capability to apply amendments to bills and generate new versions of amended bills is estimated to be as follows:

The Service Bureau has planned on having the computer capability to apply amendments to bills for some time. Accordingly, the only new money is the \$4617.00 for the "software" for the new program to generate clip sheets. Amortized over ten years, this is a little more than \$460.00 per year -- plus the cost of terminals.

SENT TO STATE OFFICES AND THE 99 COUNTY AUDITORS

- 1. 49 of the 81 state offices on the House and Senate lists responded to the questionnaire. Overwhelmingly, they wish to continue the present service.
- 2. 70 of the 99 county auditors responded to the questionnaire. 36 wished to continue the present service. 30 desire only the bills as introduced and the bills as enrolled. 4 wish the service discontinued.

From the questionnaire it appears that the service as presently provided should be continued.

Presently, we send, at least once a week, a packet containing the . Corrected Journal; orininal, reprinted, and enrolled bills; and the .clip sheets to the county auditors. The state offices pick up their packets every day.

# REPORT OF LEGISLATIVE FISCAL COMMITTEE TO LEGISLATIVE COUNCIL JUNE 12, 1974

The Legislative Fiscal Committee met in the Legislative Fiscal Bureau Conference Room on Tuesday, June 11, 1974. Members present were:

A proposed set of forms designed for reporting the status of appropriations to the Legislature during session were reviewed. Information concerning methods of reporting of other states will be acquired during the interim and a report form will be designed for use prior to the next session.

The State Comptroller will be asked to attend the next meeting of the Fiscal Committee to discuss the format of the Governor's Budget Book.

The Governor's item vetoes were reviewed and suggestions for changing legislation relating to the item veto were discussed.

The Fiscal Committee reviewed a request from the Executive Council concerning funding the Commission on Judicial Qualifications. This Commission was created by the 1973 session of the General Assembly (Chapter 285) and was not funded. The Court Administrator has requested the sum of \$7,730 from the Executive Council Contingency Fund for per diem for the seven member commission, travel and operating expense for the balance of this biennium.

The request from the Executive Council stated as follows:

"The Executive Council . . . deferred taking . . . action relative to this request and directed that the Legislative Fiscal Director get an indication from the Legislative Council membership that the Executive Council of Iowa has the authority to provide the funding requested from the Executive Council General Contingency fund."

The Fiscal Committee voted to recommend that the Council grant this authority.

In further action by the Committee, the Resolutions referred to the Fiscal Committee were assigned to the Visitation Committees.

The Committee approved a motion enlarging upon HCR 166, Study of Underground Water Supply, and asked that this study include a review of the responsibilities of the Department of Environmental Quality, Geological Survey, Natural Resources Council and the Department of Health to determine if there is overlap of responsibilities in this area.

#### OFFICE OF CITIZENS' AIDE

Members of the Legislative Service Committee make the following recommendations:

- 1. The Citizens' Aide be authorized to hire an additional secretary within the salary range recommended by the Merit Department.
- 2. The proposed salaries submitted by the Citizens' Aide which would take effect July 1, 1974 be approved. The salaries will be \$22,500 for the Citizens' Aide; \$14,512 for the first deputy; \$12,900 for the second deputy; \$7,725 for the confidential secretary; and approximately \$5928 for a new secretary.
- 3. The allocation of the budget of the Office of the Citizens' Aide be approved as submitted by the Citizens' Aide.
- 4. The Citizens' Aide be authorized to hire a third-year law student as a summer employee at a rate of \$3.00 per hour.
- 5. The Legislative Council take action on the proposal of the Citizens' Aide which requests that the first deputy and the second deputy be given retroactive salary increases from January 1, 1974 to June 30, 1974 of \$500 and \$750, respectively.

The Studies Committee makes the following report to the Legislative Council of its June 11 meeting:

- 1. That the membership on interim study committees which were approved by the Legislative Council at its May meeting be as contained in the attached listing.
- 2. That the interim study committees approved by the Council may recommend for membership a number of nonlegislative members, including persons who were previously members of study committees, not to exceed one-half the legislative membership of the study committee except in unusual circumstances.
- 3. That the name of the Local Funding and Budgeting Study Committee be changed to Local Services Study Committee because the area of the study is expanded.
- 4. That two additional members of the Human Resources Sub-committee of the Committee on Appropriations be added to the membership of the Mental Health and Juvenile Institutions Study Committee as specified in HCR 128 which was assigned to the Study Committee.
- 5. That HCR 124 recommending a study of the means to aid the deaf and persons with impaired hearing be referred to the Elderly and Handicapped Study Committee.
- 6. That the Committee received a response from Senator Curtis, Chairman of the Committee on State Government, in which he appointed members to a subcommittee to study motor vehicle registration procedures and the registration fee formula.
- 7. That the Committee received correspondence from Senator Riley, Chairman of the Senate Committee on Judiciary, in which he appointed members to a subcommittee to review the Criminal Code and in which he questioned the necessity of appointing subcommittees to study the mechanic's lien laws and the Uniform Residential Landlord Tenant Act. The Committee affirms the decision of the Legislative Council that joint subcommittees of the Senate Committee on Judiciary and the House Committee on Judiciary and Law Enforcement be appointed for the studies.
