REPORT OF THE COMPUTER OUTREACH COMMITTEE OF THE LEGISLATIVE COUNCIL

June 18, 1986

The Computer Outreach Committee of the Legislative Council met on June 18, 1986, to review the results of the 1986 public access services to the legislative computer, discuss the costs of legislator access to the computer system, and consider enhancements and cost of the 1987 public access services. The Committee makes the following recommendations:

- 1. That the Legislative Council authorize the Computer Support Bureau to establish a program for legislator access to the legislative computer system and to purchase necessary equipment for the legislator access program. A copy of the estimated costs of establishing the legislator access program is attached to and by this reference made a part of this report.
- 2. That the Legislative Council set the following fees for not to exceed fifty public access users of the legislative computer system for the 1987 calendar year:
 - a. Basic service only \$600 annually
- b. Basic service with extended services including Code search, Code retrieval and Code index search \$1000 annually
 - c. Extended services only \$600 annually

- 1. The Committee nominated William Angrick for reappointment to a four-year term as Citizens' Aide, subject to Legislative Council approval and to section 601G.3 of the Code.
- 2. The Committee defeated motions for position reclassification that would have resulted in a two-step increase for reclassified employees of the Legislative Fiscal Bureau as presented by Dennis Prouty.

- 5. The Committee heard a status report on the activities of the Comparable Worth Staff Committee. All employees have been notified of their right to request review, the review timetable, the Rules of Procedure, the Consultant's Legislative Branch Classification Structure, the current pay matrix, and the request for review form.

That protection from water damage could possibly be enhanced by the installation of a floor water monitor in the Computer Room, and that the Legislative Computer Support Bureau should investigate the installation of such a floor water monitoring device as a safety precaution should water enter the Computer Room.

REPORT OF THE STUDIES COMMITTEE OF THE LEGISLATIVE COUNCIL

June 18, 1986

The Studies Committee of the Legislative Council met on June 18, 1986, to hear a presentation by Dr. John Fuller of the L.E.A.G., consider additional proposals for interim studies, and take further actions regarding the formation of interim studies, and makes the following recommendations:

- 1. That the L.E.A.G. proposals #2 and #4 under the heading of Economic Development, and the #2 under the heading of Public Finance, be authorized as rural redevelopment L.E.A.G. studies.
- 2. That the L.E.A.G. proposal #3 under the heading of education be authorized as an education L.E.A.G. study.
 - 3. That the following proposed 1986 Interim Studies be conducted.
 - (1) Public Campaign Finance 7/7 3 meetings
 - (2) Teen-age pregnancies 5/5 3 meetings
 - (3) Rural Redevelopment 7/7 3 meetings
 - (4) State Tax Reform (related to federal tax code changes) 7/7 3 meetings
 - (5) Mississippi Riverboat Gambling 5/5 3 meetings
 - (6) Teacher Salary Improvement 7/7 3 meetings
 - (7) Local Government Reorganization 7/7 3 meetings
- (8) Affordable housing, Iowa's homeless, and utility shut-offs 5/5 3 meetings
- 4. That items 1 through 3 of the list entitled "Proposed Charge for Legislative Interim Study Mandated by H.C.R. 114" be included as specific charges to that study committee.
- 5. That the issue of targeted economic development be added as a specific charge to the rural redevelopment study committee.
- 6. That the Legislative Fiscal Bureau, in conjunction with the Fiscal Committee, conduct a performance audit on board of regents capital construction procedures.
- 7. That an additional study committee be authorized for the review of matters relating to property taxes, including:
 - (a) Who is presently paying
 - (b) What they are paying for

- (c) How collected funds are spent
- (d) Effectiveness of previous tax relief measures
- (e) Alternative forms of financing costs and expenses presently financed by property taxes.
 - (f) Review of the burden of proof in property tax assessment appeals.
- 8. That specific measures be taken in conjunction with the Legislative Fiscal Bureau concerning the centralized collection and analysis of information relating to the level of expenditures and effect of such expenditures of lottery receipts.
