## REPORT OF THE STUDIES COMMITTEE TO THE LEGISLATIVE COUNCIL

June 30, 1999

The Studies Committee of the Legislative Council met on June 30, 1999, and makes the following report:

## A. The Studies Committee recommends authorization of the following studies for the 1999 Legislative Interim:

#### 1. Community College Governance System

This committee shall identify and study options for restructuring the community college governance system. The goal is to develop a plan for community colleges to operate more cooperatively, effectively, and efficiently as a state system while recognizing the strong local character of the community colleges. The committee shall review the following aspects of the current system: current governance system; ongoing collaborative efforts; relationships with local K-12 schools, other accredited postsecondary institutions, and the Department of Education; and changes necessary to enhance accountability. The committee may consult with the Office of the Governor, Iowa Association of Community College Trustees, Iowa Association of Community College Presidents, Division of Community Colleges and Workforce Preparation of the Department of Education, and other parties interested in community college governance.

#### 2. Improving School Facilities

This committee shall study and make recommendation concerning financing mechanisms for K-12 school buildings, including approaches for construction, improvements, and renovations.

This committee shall study the issue of the property taxation of condominiums (described as apartments in horizontal property regimes in Iowa Code chapter 499B). The study shall include classifications which have multiple uses.

#### 4. Loess Hills

This committee shall study issues relating to the Loess Hills, including restrictive easements and covenants as a tool to carry out projects and programs to protect, conserve, or develop various areas of the Loess Hills.

#### 5. Increasing Use of Motor Oxygenate Enhancers

This committee shall study issues and make recommendations relating to the sale, use, and health and environmental effects of oxygenate enhancers contained in motor fuel. The study shall include both ethanol and methyl tertiary butyl ether (MTBE).

#### 6. OWI Course Requirements

This committee shall evaluate courses required for persons who have committed an operating a motor vehicle while intoxicated (OWI) offense. The study shall include a review of courses offered through the community colleges, either alone or in conjunction with local licensed substance abuse agencies, and include the consideration of the practice of combining juveniles and adults in the course, authorizing and ensuring the availability of expertise to offer separate courses geared toward juveniles and adults, the potential mixed message sent to recovering alcohol or drug abusers who should be receiving a zero tolerance for use directive, enrollment procedures, course fees and costs, and course evaluation.

#### 7. Volunteer Fire and Emergency Services

This committee shall review and make recommendations regarding the legal, budget, governance, and financial aspects of volunteer fire protection services, emergency medical services, emergency warning systems, and other vital services provided under the auspices of townships. Related policy considerations involved with townships shall be addressed in order to improve the functioning of townships as viable units of local government or to integrate township responsibilities with those responsibilities of other units of local government.

## PROPOSED GUIDELINES FOR INTERIM STUDY COMMITTEES 1999-2000 INTERIM

#### **ADOPTION OF RULES**

Interim study committees must have a majority of the members representing each house voting affirmatively in order to adopt rules.

#### COMPENSATION OF PUBLIC MEMBERS

Persons serving as public members of study committees are eligible to receive actual expenses only, if they are not eligible for expense reimbursement by an organization that they represent. In order for a public member representing an organization to be eligible to receive actual expenses, the organization must submit a letter to the Legislative Council indicating that the public member is not eligible for the reimbursement from the organization. Payment of the expenses is subject to the approval of the Chairperson and Vice-chairperson of the Legislative Council.

#### STAFF WORK FOR PUBLIC MEMBERS

After consultation with, as appropriate, the Legislative Service Bureau (LSB) or Legislative Fiscal Bureau (LFB) Director, a study committee chair may authorize research or legislative drafting work by the LSB or LFB for public members of study committees.

#### APPROVAL OF NOMINEES

Public members of study committees may be nominated by designated organizations, subject to Legislative Council approval or subject to the approval of the chair and vice chair of the Legislative Council in consultation with the minority leaders of the Senate and House of Representatives.

#### GENDER BALANCE

Appointment of public members to study committees shall be gender balanced.

#### **VOTING BY PUBLIC MEMBERS**

Unless otherwise provided by the General Assembly or the Legislative Council, public members of study committees are nonvoting.

#### APPROVAL OF MEETINGS OUTSIDE DES MOINES

Any meeting or public hearing by a study committee held outside of Des Moines requires the prior approval of the Studies Committee or legislative leadership.

#### **PUBLIC HEARINGS**

When authorization is given for a study committee to hold a public hearing, the committee may hold one hearing as a body or individual members may each hold a public hearing or groups of two or more members may hold public hearings. However, for each authorized public hearing, no members of the study committee may receive compensation for attendance at more than one session.

#### APPROVAL OF EXPENSES FOR SPEAKERS AND CONSULTING WORK

Any expenditure by a study committee for a speaker or presentation requires the prior approval of the Studies Committee and Legislative Council, or legislative leadership. Contractual consulting work for a study committee requires the prior approval of the Studies Committee and the Legislative Council.

#### SCHEDULING GUIDELINES

If the Legislative Council adopts deadlines for meeting dates of an interim study committee, the interim study committee must meet those deadlines or receive an exemption or a revised deadline date from the Legislative Council.

Re: E-mail Chain Letter and Outrageous Content Guideline Suggestions

## OFFICIALS' AND EMPLOYEES' USE OF LEGISLATIVE COMPUTER SYSTEM

- 1. Definitions. For purposes of this policy:
- a. "Electronic mail chain letter" includes but is not limited to commercial offers, getrich schemes, superstitious and good-luck letters, contests, and commercial promotions.
- b. "Legislative computer system" includes but is not limited to the General Assembly's mainframe, personal computers, and networks, including functionalities allowing the use of electronic mail and the Internet.
- c. "Significantly and adversely affects" includes but is not limited to making threats of workplace or other violence, electronic mail spamming, sending of electronic mail chain letters, and sending of electronic mail messages containing sexually explicit or sexually offensive content.
- Use by Legislative Official or Employee. A legislative official or employee shall
  not use the legislative computer system in a manner which is contrary to statute
  or legislative rule or policy, or which significantly and adversely affects the
  General Assembly.
- 3. Related Criminal Code Provision. Legislative officials and employees should familiarize themselves with Iowa criminal code section 721.2(5) which prohibits

use of property owned by the state for any private purpose and for personal gain, to the detriment of the state.

#### 721.2 Nonfelonious misconduct in office.

Any public officer or employee, or any person acting under color of such office or employment, who knowingly does any of the following, commits a serious misdemeanor:

- 1. Makes any contract which contemplates an expenditure known by the person to be in excess of that authorized by law.
- 2. Fails to report to the proper officer the receipt or expenditure of public moneys, together with the proper vouchers therefor, when such is required of the person by law.
- 3. Requests, demands, or receives from another for performing any service or duty which is required of the person by law, or which is performed as an incident of the person's office or employment, any compensation other than the fee, if any, which the person is authorized by law to receive for such performance.
- 4. By color of the person's office and in excess of the authority conferred on the person by that office, requires any person to do anything or to refrain from doing any lawful thing.
- 5. Uses or permits any other person to use the property owned by the state or any subdivision or agency of the state for any private purpose and for personal gain, to the detriment of the state or any subdivision thereof.
- 6. Fails to perform any duty required of the person by law.
- 7. Demands that any public employee contribute or pay anything of value, either directly or indirectly, to any person, organization or fund, or in any way coerces or attempts to coerce any public employee to make any such contributions or payments, except where such contributions or payments are expressly required by law.
- 8. Permits persons to use the property owned by the state or a subdivision or agency of the state to operate a political phone bank for any of the following purposes:
- a. To poll voters on their preferences for candidates or ballot measures at an election; however, this paragraph does not apply to authorized research at an educational institution.
- b. To solicit funds for a political candidate or organization.
- c. To urge support for a candidate or ballot measure to voters.

#### ITS Email Policy Regarding Email Chain Letters

The State's policy regarding the personal use of State equipment will serve as the basis for addressing email chain letters. Email chain letters are inappropriate in a workplace environment and a waste of system resources. It is the policy of ITS that all employees shall refrain from using State email systems for the distribution of such letters. Employees receiving email chain letters shall note the sending party's email address and report it to their immediate supervisor. Do not reply to email chain letters and instead, delete them immediately. "Email chain letter" is defined to include, but not be limited to: commercial offers, get rich quick schemes, superstitious and good luck letters, contests, commercial promotions, and charitable solicitations (except those sponsored by ITS or State Government such as One Gift).

As a matter of advice, but not policy, our Attorney General's Office of Consumer Protection consistently advises: "Anything your common sense tells you is too good to be true IS too good to be true."



**COURT RULES** 

Under Section 602.4202 of the Iowa Code, the Supreme Court is required to submit Court Rules changes to the Legislative Council and the rule takes effect 60 days after its submission to the Legislative Council or at a later date specified by the Court. The amendment to the Iowa Rule of Criminal Procedure submitted by the Court is scheduled to take effect 60 days after the submission to the Legislative Council unless the Legislative Council delays the effective date.

The rule change amends Rule of Criminal Procedure 4.2. In 1999 the Legislature amended section 903.1 and this rule change puts the rule in compliance with that statutory change.





#### Rule 4. Indictment.

2. Use of indictment. Criminal offenses other than simple misdemeanors in which the punishment exceeds a fine of one hundred dollars or exceeds imprisonment for thirty days may be prosecuted to final judgment either on indictment or on information as provided in R.Cr.P. 5.

. . . .

A person, firm, copartnership, or corporation who offers for sale, exposes for sale, sells at retail, or uses or explodes any fireworks, commits a serious simple misdemeanor. In addition to any other penalties, the punishment imposed for a violation of this section shall include assessment of a fine of not less than two hundred fifty dollars. However, the council of a city or a county board of supervisors may, upon application in writing, grant a permit for the display of fireworks by municipalities, fair associations, amusement parks, and other organizations or groups of individuals approved by the city or the county board of supervisors when the fireworks display will be handled by a competent operator, but no such permit shall be required for the display of fireworks at the Iowa state fairgrounds by the Iowa state fair board, at incorporated county fairs, or at district fairs receiving state aid. Sales of fireworks for such display may be made for that purpose only.

- Sec. 23. Section 730.4, subsection 6, Code 1999, is amended to read as follows:
- 6. A person who violates this section commits a serious simple misdemeanor. In addition to any other penalties, the punishment imposed for a violation of this section shall include assessment of a fine of not less than two hundred fifty dollars.
- Sec. 24. Section 903.1, subsection 1, paragraph a, Code 1999, is amended to read as follows:
- a. For a simple misdemeanor, either-imprisonment-not-to exceed-thirty-days, or there shall be a fine of at least fifty dollars but not to exceed one five hundred dollars. The court may order imprisonment not to exceed thirty days in lieu of a fine or in addition to a fine.

- 1. When revoking a defendant's driver's license under section 321J.4, the court shall not consider a conviction under section 321J.2 which occurred on or prior to June 30,
