LEGISLATIVE FISCAL COMMITTEE MEETING AUGUST 14, 1973

The attached schedule of requests by the Visitation Committees was approved with the exception of the State Departments Visitation Committee meeting with the Iowa Beer and Liquor Control Council. Approval of this request was deferred until the September meeting pending action by the Council resulting from the appearance of Mr. Gallagher before the Council today.

The Legislative Fiscal Committee approved the request for three staff members of the Legislative Fiscal Bureau to attend the Legislative Fiscal Review Training Program in Denver, Sept. 12-15, subject to Council approval.

Also approved was a request for the Legislative Fiscal Director to attend the Legislative Post Audit Training Program to be held in Madison, Wisconsin September 17-19.

The Committee further authorized six committee members to attend whichever of the above two training programs they desire to attend, subject to Council approval.

A subcommittee comprised of Representative Lipsky, Representative Small, and Senator McCartney was appointed to review information on microfilming to make a recommendation to the full committee on the need for a comprehensive study to determine if a centralized microfilming Division is needed in State Government.

 - b. Following the general election legislators who will not be returning as a member of the succeeding general assembly should not be authorized out-of-state travel except in the case where he is participating in the out-of-state meeting in an official capacity.

REPORT of the LEGISLATIVE SERVICE COMMITTEE

August 15, 1973

The Legislative Service Committee met on August 14, 1973 and makes the following recommendations to the Legislative Council:

- 1. That Larry Burch be employed as a Legal Counsel by the Legislative Service Bureau commencing August 7, 1973 at a beginning salary of \$11,000.
- 2. That the plans for double decking the north and south wings of the Legislative Service Bureau area as submitted by Mr. Frank Bunker be approved, subject to the heating and air conditioning being properly coordinated with an overall plan for heating and air conditioning of the legislative areas of the State House.
- 3. That the heating and air conditioning of the legislative areas of the State House be planned and installed essentially as a single unit.
- 4. That personal interviews of twenty minutes each be set up for August 22, 1973 for the following candidates for Citizens' Aide: Douglas Carlson, Robert Eaton, Mrs. Adriana Greffenius, Richard Howe, Roger Iverson, Thomas Mayer, Max Smith, and Mrs. Beverly Stubbee.

REPORT OF STUDIES COMMITTEE TO THE LEGISLATIVE COUNCIL August 15, 1973

The Studies Committee met on August 15, 1973 and reviewed the requests for interim subcommittee work submitted by the chairmen of the standing committees. The following requests were approved and are recommended to the Legislative Council:

- 1. Uniform State Administrative Procedures Act Subcommittee appointed by the chairmen of the Standing Committees on State Government. 5 members from each House with 3 meetings authorized. It is also suggested that the chairmen of the Standing Committees on State Government select members from their committees who are attorneys or members of the Standing Committees on Judiciary.
- 2. Uniform Alcoholism and Intoxication Treatment Act Subcommittee appointed by the chairmen of the Standing Committees on Human Resources. 5 members from each House with 3 meetings authorized. Not less than 2 members from each House appointed to this subcommittee shall be appointed from the Standing Committees on State Government.
- .3. No-Fault Insurance Subcommittee appointed by the chairmen of the Standing Committees on Commerce. 5 members from each House with 2 meetings authorized.
- 4. Collective Bargaining Subcommittee appointed by the chairman of the House Committee on Human and Industrial Relations. 5 members for the purpose of reviewing the collective bargaining bill passed by the Senate with 3 meetings authorized.

The Studies Committee makes the following recommendations to the Legislative Council regarding membership and number of meetings of standing committee subcommittees previously approved by the Council:

- 1. That the Criminal Justice System Subcommittee of the Standing Committees on Judiciary be composed of 6 members and authorized to hold not more than 4 meetings.
- 2. That the Federal Highway Safety Standards Subcommittee of the Senate Standing Committee on State Government and the House Standing Committee on Transportation be authorized a total of 6 members and no more than 2 meetings.
- 3. That the Agricultural Promotions Subcommittee of the Standing Committees on Appropriations be authorized 10 members with a maximum of 2 meetings.

- 4. That the Cable Television Subcommittee of the Standing Committees on Commerce be limited to 6 members and not more than 3 meetings.
- 5. That the Insurance Companies and Net Worth Tax Subcommittee of the Standing Committees on Ways and Means be composed of 10 members and allowed not more than 3 meetings.
- 6. That the Uniform Vehicle Code Subcommittee of the Senate Standing Committee on State Government and the House Standing Committee on Transportation be composed of 6 members and allowed not more than 4 meetings.
- 7. That the Problems of the Elderly and Handicapped Subcommittee of the Standing Committees on Human Resources be composed of not more than 6 members and be allowed no more than 3 meetings.
- 8. That the Criminal Code Revision Subcommittee of the Standing Committees on Judiciary be composed of 10 members and permitted no more than 3 meetings.
- 9. That the Functional Classification of Highways Subcommittees of the Senate Standing Committee on State Government and the House Standing Committee on Transportation be composed of 3 members of the Senate, 5 members from the House and be permitted no more than 3 meetings.
- 10. That the Department of Transportation Subcommittee of the House Standing Committee on Transportation and the Senate Standing Committee on State Government be composed of 6 members and be allowed no more than 3 meetings.
- 11. That the Special Education Programs Subcommittee of the Senate Standing Committee on Schools and the House Standing Committee on Education be authorized 10 members with a maximum of 4 meetings.

The Studies Committee also recommends that Representative David Stanley be appointed to replace Representative George Knoke as a member of the Uniform Commercial Code Study Committee.

The Studies Committee also recommends that Senator John Murray be named to replace Senator Barton Schwieger as a member of the Mental Health and Juvenile Institutions Study Committee. Senator Schwieger has indicated that his schedule is such that he would be unable to serve on this study committee.

The Studies Committee was also informed that Representative Jay Mennenga had indicated his desire not to serve on the Uniform Commercial Code Study Committee and after discussion agreed that the chairman of the Studies Committee appoint a member of the House to replace Representative Mennenga, after consultation with Representative Edgar F. Holden and Representative Dale M. Cochran.
