To: Members of the Legislative Council

On August 19, 1975, we received bids for the remodeling of the House space. I am pleased to report that the low bid was for \$103,406, which was far below our original estimate. The firm submitting the low bid is Breiholz Construction Company of Des Moines, a very reputable firm which will use established respected subcontractors. I recommend that the Breiholz bid be accepted.

Also, on projects of this nature it is often necessary to have change orders. I propose that with the approval of Speaker Dale M. Cochran and Lieutenant Governor Arthur A. Neu, I be given the authority to spend up to an additional \$5,000 if a change is necessary. Because of the tight schedule on which we will be operating, it might be difficult to finish on time (December 15) if we have to halt work while we wait for a full meeting of the Council.

STUDIES COMMITTEE OF THE LEGISLATIVE COUNCIL

August 20, 1975

The Studies Committee of the Legislative Council makes the following recommendations to the Legislative Council:

1. That a subcommittee be appointed to study the Uniform Vehicle Code. The Subcommittee shall be composed of 3 members from each House. Two members from each House shall represent the Committees on Judiciary and one member from each House shall be selected from the Committee on Transportation. Both political parties shall be represented. The chairman of the respective committees shall select the members and report their selections to the Legislative Council.
2. That a Subcommittee be appointed from the Committees on Judiciary from both Houses to study an appellate court system. Five members shall be selected from each House representing both political parties. The chairmen of the respective committees shall appoint the members.
3. That Representative Joyce Lonergan be appointed to the Department of Social Services Study Committee to replace Representative William Monroe. In addition Representative Tom Higgins and Senator Richard Ramsey shall be appointed to this study committee.
4. That the Penal and Correctional Systems Study Committee be authorized to appoint an advisory committee composed of various qualified persons which persons would be authorized to attend meetings of the Committee in the manner and pursuant to the procedures recommended by the Committee and submitted by Representative Donald Doyle.
5. That Senator Fred Nolting be appointed as an additional member of the Property Taxation Study Committee.
